PLEA ON AIR TO CONCLUDE CAMPAIGN

Governor to Spend Last Day on Visit to Residents of Own County

HYDE PARK, N. Y., Nov. 7 (I.N.S.).—Back among the home folks in the Hudson River Valley where he launched his political career 22 years ago, Gov. Franklin D. Roosevelt today came to the end of his long and strenuous campaign for the presidency, supremely confident of a Democratic landslide at tomorrow's election.

The Governor was to set out this afternoon on a "sentimental" motor trip through several towns along the Hudson and today, in Poughkeepsie, he will make his final appeal to the nation in a half hour radio talk. He may take one last fling at President Hoover and the Republican leadership, but his final speech will be mainly an appeal to "get out and vote."

Visited 38 States: Although he was carried his campaign from coast to coast through 38 States, covering upwards of 20,000 miles by train and automobile, Governor Roosevelt insisted upon following the custom he established many years ago of visiting the home folks on the day before election. He said: "I couldn't close this campaign without calling on my old friends and neighbors."

Twenty-two years ago, Roosevelt, then a youth just out of Harvard, made his first campaign speech in the public square at Beacon as a candidate for the State senate. This afternoon on the same spot, he will speak as a candidate for the highest office (Continued on Page 2, Col. 2)

STOCKS SPURT 1 TO 4 POINTS

NEW YORK, Nov. 7 (I.N.S.). The bulls were in complete control of the stock market today and sent prices whirling up from 1 to more than 4 points in heavy trading.

Bonds and commodities went up with stocks. Wheat rose about a cent a bushel, with Liverpool recovering from its recent weakness.

Considerable European buying was reported in the market following Hitler's setback at the German polls yesterday.

The rails were among the best performers, with Union Pacific setting the pace, spurring more than 4 points. Saturday's decline in car loadings was ignored.

Leading stocks were outstandingly strong. American Telephone spurted nearly 4 points as the shorts were sent scrambling to cover. Allied jumped 4 points against the bears. Consolidated Gas was up about 3 points.

SEARCH RULING HITS AT DRYS

The Supreme Court today ruled that a search warrant cannot be issued to prohibition agents for search of a private residence unless there is real evidence that the place is being used for the sale of liquor.

The high court made its ruling in reversing conviction and five year sentence of William Grau, of Newport, Ky. He was convicted of manufacturing liquor.

The evidence claimed by an agent who gets a search warrant should be of the kind that would be admitted at a trial, Justice Roberts said.

Justices Stone and Cardozo dissented.

HOOVER CITES 'CAMPAIGN OF HATE'

President Offers Sugar Tariff As Bait in Utah Speech; On Radio Tonight

MORMON TABERNACLE, SALT LAKE CITY, Utah, Nov. 7 (I.N.S.).—By "misrepresentation" and "irresponsible" tactics the Democrats have sought to build up a "personal hate" against the Administration that is designed to elect Franklin D. Roosevelt tomorrow.

This was the charge made today by President Hoover at Salt Lake City before a packed crowd in the Mormon Tabernacle. He said:

"That is making politics out of human misery."

Tonight, over the radio, Mr. Hoover will ask all citizens to exercise their franchise. In so far as the issues at stake in the campaign were concerned, however, he spoke his last word here.

Calls Charges False

The President declared that all of the charges lodged against him were baseless and countered with the suggestion that most of the promises made by Governor Roosevelt could not be eventuated—or else were in accord with proposals already made from the White House.

Application of the Democratic program, the President said, would destroy those principles upon which the nation was based and force America to join the "decaying nations" of the world.

Mr. Hoover analyzed the strategy of his opponents for his audience. First, he said, they are relying on the "Solid South." Second, they would add their political brigades in the big cities.

Beet Sugar, Topic

Then, by misrepresentations and nebular promises which can never be fulfilled, he said, they are appealing to the unemployed, the farmers, the miners, and other ranks in which disaffection might be expected to be inspired easily.

He said:

"Their failure will be the result."

COX SURE OHIO ROOSEVELT'S

NEW YORK, Nov. 7 (I.N.S.). Optimistic reports poured into Democratic national headquarters here today on the eve of the elections.

Former Governor James M. Cox, of Ohio, Democratic presidential candidate in 1920, in a telephone conversation with James A. Farley, chairman of the Democratic national committee, predicted that Governor Franklin D. Roosevelt, Democratic presidential nominee, would carry Ohio by more than 300,000 votes. Farley said:

"Last-minute reports from precinct chairmen all over the country giving their best estimates as to the outcome in their districts is conclusive that Franklin D. Roosevelt and John N. Garner will be elected President and Vice President and that the vote will surpass our fondest hopes and our most optimistic predictions."

O'BRIEN TO WIN BY 550,000

NEW YORK, Nov. 7 (I.N.S.).—Tammany's candidate for mayor of New York city, Surrogate John P. O'Brien, will in all probability be elected tomorrow, but, according to advance predictions, he will run far behind the Democratic national and State tickets.

O'Brien will win by an estimated plurality of about 550,000, whereas Gov. Franklin D. Roosevelt's plurality in New York city is expected to run as high as 950,000—maybe 1,000,000 votes.

Tammany is supporting Roosevelt as well as O'Brien, despite the firm manner in which Governor Roosevelt dealt with former Mayor James J. Walker when the latter came before him on the Seabury charges.

Hoover's Train Runs Into Snow In Wyoming

ABOARD PRESIDENTIAL TRAIN EN ROUTE TO CALIFORNIA, Nov. 7 (I.N.S.).—President Hoover's special train which is speeding him westward to California to vote ran into a light snow last night between Laramie and Rawlins, Wyo.

Those aboard the special seemed fascinated by the sight of snow on the tracks and sidings and got off at each stop to make a closer inspection.

Even the vestibules of the train had a light covering.

DEMOCRAT RAIN FOR ELECTION

"Democratic weather" will prevail tomorrow in a great portion of the United States, the Weather Bureau predicted today.

Even New England, set apart as the Republican stronghold, will go to the polls under umbrellas and raincoats, according to the Government experts.

Only in the Far West is fair weather expected, and there the exceptions will be Washington and Oregon, where rain is the forecast.

The Midwest agricultural States are to experience rains or light snows.

West Virginia, Kentucky, and Tennessee, which usually give the Democrats the jitters, will also line up at the election booths in their rubber boots and overcoats.

The South and Southwest are in for "mostly rain," so all in the old weather adage apropos of politics, is giving the Grand Old Party no whit of comfort.

GOV. ROOSEVELT COURT SPARES ODDS JUMP 7 NEGROES

CHICAGO, Nov. 7 (I.N.S.).—As the Presidential election draws near, odds are going up in favor of Gov. Franklin D. Roosevelt, a New York and Chicago brokerage firm, announced today.

The company said it had received \$100,000 to bet on Roosevelt against \$20,000 on Hoover.

Odds for the various States were reported today as follows:

NEW YORK, Roosevelt, 5 to 2; Ohio, Roosevelt, 3 to 1; Illinois, Roosevelt, 3 to 1; Kentucky, Roosevelt, 3 to 1; Michigan, Roosevelt, 3 to 1; Rhode Island, Roosevelt, even; Virginia, Roosevelt, 5 to 1; Wyoming, Roosevelt, 7 to 5.

Alabama, Arizona, Arkansas, Florida, Louisiana, North and South Carolina and Tennessee were quoted 15 to 1 for Roosevelt. Georgia and Texas are 20 to 1 for Roosevelt. California is 4 to 1 for Roosevelt. Others are: Colorado, 8 to 5; Delaware, even; Idaho, 7 to 5; Indiana, 6 to 5; Iowa, 6 to 5; Kansas, even; Maryland, 5 to 1; Minnesota, 7 to 5; Mississippi, 4 to 1; Missouri, 5 to 1; Montana, 8 to 5; Nebraska, 8 to 5; Nevada, 8 to 5; New Jersey, even; New Mexico, 5 to 1; North Dakota, 8 to 5; Ohio, 7 to 5; Oklahoma, 6 to 5; Oregon, 8 to 5; South Dakota, 3 to 1; Utah, 6 to 5; Washington, 7 to 5; West Virginia, 7 to 5; Wisconsin, 8 to 5. Odds favoring Hoover are Connecticut, 8 to 5; Maine, 2 to 1; Massachusetts, 6 to 5; New Hampshire, 2 to 1; Pennsylvania, 7 to 5; Vermont, 8 to 7.

The Supreme Court today set aside the conviction and death sentences of seven young negroes convicted at Scottsboro, Ala., of assaulting two white girls.

The opinion in the case, which has attracted wide attention was read after police had repulsed radicals attempting a demonstration on the Capitol Plaza.

Justice Sutherland delivered the opinion.

In appealing to the high court, counsel for the negroes contended they were denied a fair trial, a contention vigorously denied by spokesmen for the State of Alabama.

The negroes' counsel alleged that the National Guard was on duty during the trial, that negroes were excluded from the jury panel, that they were not given proper defense assistance, that newspapers inflamed the populace which crowded Scottsboro, and that the whole trial was conducted under threat of mob violence.

Denying this, Attorney General Knights of Alabama said reputable members of the bar were named as lawyers for the negroes, but made no attempt to do so, that negroes were not systematically excluded from jury service, and that the sheriff summoned the National Guard as a result of over caution.

Communists Use Banners As Weapons; Suspects Mostly Outsiders

Ten men and four women were arrested today in a battle on Capitol Plaza between Communists and the police in the course of which one tear gas bomb was exploded by the police.

The occasion was the attempt of some 75 or 100 Communists to picket the Supreme Court of the United States, which convened today and preceded the decision setting aside the death verdicts in the case of seven negroes, sentenced to death at Scottsboro, Ala.

The Communists, following a well-planned routine, suddenly appeared in the Capitol grounds, shouting:

"Justice for the Scottsboro boys."
At the same time, they waved aloft banners bearing that legend and others proclaiming:

"Death to the lynchers."

Policemen Attacked

As the marchers suddenly appeared, Pvt. George B. Walker, of the Capitol police, sought to stop them. The vanguard moved by him, shouting lustily, but he clashed through the rear guard and came to grips with a burly colored man, who began wielding the stick on which his banner was attached.

Other Communists did likewise. From the sidewalk a civilian, armed with an umbrella, entered the melee and began cracking Communist heads.

Walker, unable to cope with the situation, drew his service revolver, but before he could fire it he was rescued by plain clothesmen.

At this stage, Inspector Albert J. Headley, leading about 100 policemen, who had been on duty on the plaza all day, reached the head of the column.

Woman Leader

Inspector Headley grabbed a woman who was leading the march and the column halted. Inspector Headley then said:

"Who are your leaders?"

He received no reply and then said:

"Surely you must have a leader. You ought to know you cannot come on the Capitol grounds with banners and placards."

Someone in the Communists' ranks yelled:

"It is our constitutional right."

Inspector Headley did not stop to argue the point but began snatching down banners in the front ranks. His command did likewise. Some few Communists resisted, striking back at the policemen and several billies were wielded by the officers.

Bomb Set Off

In the excitement, a tear gas bomb was let off and the Communists, dropping their placards, (Continued on Page 2, Col. 5)
